Scholarship Application Cover Sheet

Description of Scholarship: \$2000 per year, the SGCCF Scholarship will be awarded annually, and is renewable for up to four years provided the student continues to meet requirements. The Community Foundation is seeking to reward character, leadership, and academic performance in our local students, and to support their educational and career goals.

Description of Criteria: Student has demonstrated their commitment to their community and to their school performance. Applicants will be required to provide two letters of recommendation describing their leadership, character, and examples of their efforts for their school and their community. Other criteria for evaluation will include scholastic aptitude index, academic record, school activities, need, and community service.

Filling out the Application: Obtain an electronic copy of the application from your school counselor. Fill out the application using as much space under each item as needed. Print out a copy, sign it, and have your school counselor sign it.

Review of Applications:

Please return completed application to your school counselor through their email. They will need to verify your class rank, GPA, and ACT scores. Also in the email, attach two (2) letters of recommendation. These can be in Word Document, or a scanned hard copy. The Foundation committee will only consider applications that are forwarded to us through your counselor. These applications will need to be received by your counselor by 3:00 PM Wed. February 26, 2014 to be considered for an award.

Applications will be reviewed by the SGCCF, with an expected award date of April 1st or shortly thereafter.
